FINANCIAL INFORMATION & POLICIES

Tuition

Note: Plan A receives a 3% reduction in tuition & fees and Plan B receives a 1% reduction in tuition & fees (no discount applies to payments made by credit card).

Plan A: Single Payment -- 100% of tuition, less the enrollment deposit (10%), is due by July 1, 2010.

Plan B: Semi-Annual Payments -- 50% of tuition is due by July 1, 2010 and 50% of tuition (less deposit of 10%) is due by December 1, 2010.

Plan C: Monthly Payments -- 8 equal payments due by the first of each month beginning July 1, 2010 and ending February 1, 2011. The enrollment deposit will be applied toward the last tuition payment.

Enrollment, as specified within the enrollment contract, may be cancelled in writing prior to August 1, 2010 resulting in forfeiture of the 10% non-refundable deposit. If the enrollment contract is cancelled after August 1, 2010 the parents or guardians financially responsible for the student forfeit the non-refundable enrollment deposit as well as an additional 10% of the total tuition and fees for the academic year.

Academic Skills Center: Educational assessments and testing, along with individual and small group private tutoring, are available for elementary and middle school students for an additional fee (separate application available).

Activity Fees (included in tuition fees): Additional charges for most field trips and physical education programs are included in tuition.

Application Fee: A one time, non-refundable, \$50 application fee is required for each child.

Child Care Only Days: The School provides a Child Care Program for school vacations & parent/teacher conference days for an additional fee. These weeks are marked *Child Care Only* on the school calendar and are available to students enrolled in academic day programs at an extra charge of \$45 per day and to students enrolled in academic day programs with child care blocks at an extra charge of \$55 per day. The contract for these days will be available in October and must be submitted no later than 11/15/2010. Students may not exceed their normal schedule during these weeks. There will be no refunds given for any reason and enrollment only as space allows after 11/15/2010.

Extended Hours: Extended hours beyond the contracted time must be scheduled and approved in advance. The School is open between 7:30 AM and 5:30 PM. Within this time period, hours beyond the contracted time may be arranged on a day to day basis only as space permits. All charges are due and payable when billed at a rate of \$10.00 per hour (with a \$10.00 minimum).

Hours: The School is open Monday through Friday, from 7:30 AM to 5:30 PM, 12 months of the year. Please see the School Calendar for information on scheduled School closures.

Late Payment: Non-Payment of tuition will result in mandatory withdrawal from the School. Payments greater than 10 days past due will be assessed a late payment fee of \$25.00 and the student may be suspended from the School until all tuition and late fees are paid. Accounts greater than 30 days past due will be assessed a finance charge of 1.5% of the past due balance per month. The School reserves the right to take legal action for collection of unpaid tuition and fees. Parents will be held responsible for all costs of collection of unpaid fees, including court expenses and attorney's fees.

Late Pick-Up Fee: The School closes at 5:30 PM. There is a charge of \$10 per ¼ hour or any part of a ¼ hour for pick-up after 5:30 PM.

Non-Refundable Enrollment Deposit: A non-refundable enrollment deposit of 10% of the total tuition and fees is due upon return of the enrollment contract on or **before February 1, 2010** and will be held and applied toward your last tuition installment. **The deposit will be forfeited to the School if the student is withdrawn before the end of the Academic Year (June 2011) for any reason.** For new students accepted after February 1, 2010, the full deposit is due, with the tuition contract, within 2 weeks of acceptance or on the first day of school, whichever comes first. **The enrollment deposit may only be applied toward the student's tuition for the academic year 2010-2011 and is not refundable for any reason.**

Physical Education: All Kindergarten, Elementary and Middle School students participate in the physical education program. These programs are mandatory and the cost is included in the tuition. A doctor's note is required for non-attendance.

Returned Checks: If the bank returns a check for any reason, a fee of \$20 will be charged. Cash or certified checks will be required after 2 returned checks.
